Advocacy

Summary of Advocacy Efforts and Issues

- Director of Advocacy has engaged in ongoing communication with ILOTA Lobbyist & ILOTPAC related to legislative/advocacy issues
- Created an Advocacy Advisory Group to connect with experts in various practice areas
- Designed spreadsheet to link IL representatives with ILOTA members in their districts to facilitate advocacy with individual representatives
- Outreach:
 - Participated in a telehealth roundtable discussion for school-based OT practitioners
 - Presented to a local university OT program about advocacy
- Early Intervention (EI):
 - Sent a letter to the Illinois Commission on Equitable Early Childhood Education and Care Funding to advocate for OT representation on the commission
 - Alerted ILOTA members to a letter writing campaign to request support for the use of telehealth in EI from state representatives and senators
 - ILOTA EI SIS committee members have been meeting regularly; are in regular communication with the ILOTA Lobbyist, the Ounce of Prevention, and the IL EI Bureau; and are ensuring OT representation on the Illinois EI Interprofessional Coalition, the Illinois Interagency Council on Early Intervention, and within Reopen Illinois work group meetings
- Telehealth:
 - Home & Community Health, Pediatrics, and EI SIS committee members have collaborated on a telehealth research survey
 - Various meetings between Director of Advocacy, Home & Community Health SIS Chair, ILOTA Lobbyist, and Senator Harmon to discuss and revise SB 27 regarding telehealth
- Medicaid:
 - Engaged in various discussions regarding Medicaid telehealth pay differential
- School-based Practice:
 - Began collaborating with School-Based Practice SIS Chair and an OTD Capstone student to further explore advocacy for OT eligibility for Professional Educator License
- OT Licensure Compact:
 - Attended AOTA presentation about the proposed compact
 - Participated in a meeting with representatives from AOTA, NBCOT, and National Center for Interstate Compacts to discuss Illinois' participation in the compact
