 - In-person Poster Session
 - Virtual 1.0-hour Pre-Recorded Short Course
- Main Presentation Focus
 - Research-oriented, or
 - Practice-oriented
- Consideration for Virtual Presentation: For speakers submitting a proposal for IN-PERSON Courses, would you be interested in converting your proposed presentation into a VIRTUAL pre-recorded course if we are not able to accept your proposal for the IN-PERSON session?
- In-Person Presentation Day Preference: The 2025 conference will be returning
 to a two-day conference on Friday & Saturday. While we cannot guarantee the
 day you will be scheduled to present, the committee would like to take

 MUST be submitted ready for publication. Please ensure proper spelling,
 grammar, and punctuation.
- Presentation Abstract: Provide a 2-3 paragraph description of your proposed presentation/discussion that provides details of the purpose of the presentation, explains the relevance of your presentation to occupational therapy, and includes



references to demonstrate that your presentation is evidence-informed and occupation-focused.

- **Learning Objectives:** Please identify 2-3 learning objectives. Should be specific and complete the statement: "At the conclusion of this session, participants will be able to..."
- **Speaker Qualifications** (400-character limit including spaces): Please include a brief statement about qualifications of the speaker(s) relative to the proposed topic. DO NOT include names of affiliations of speakers or authors. During the final selection of proposals, qualifications of the speaker(s) may be considered when more than one proposal addresses the same or similar topic area
- Reference List: Include a complete list of evidence-informed resources cited in your presentation (books, journal articles, websites, etc.)
