 - Bills that were recycled: co-insurance parody bill for PT; unlimited PT for MS patients; Athletic Trainers Act (HB 3020) removes all supervision of physician, can work on anyone, allows therapeutic intervention in most therapy arenas (national trend, moving to masters level entry by 2022), encroachment on OT practice areas—none of these bills passed, but will return again
 - State budget has been main focus
